For those of you who are new and just learning about the library, and for those of you who have been using the library for years, this publication is designed to highlight our library's services, resources and collections.

What's New?

Our big project for the summer was the installation of compact shelving on the ground floor of the library. This was a major renovation, and required relocating and re-organizing a majority of the collection. The locations of major collections are listed below:

- Government documents and archived materials are located in the compact shelving on the ground floor

- All loose-leafs are located on the ground floor
- Federal, state, and regional materials are located on the second floor
- Treatises and monographs are located on the second floor
- Serials and law reviews are located on the third floor

Floor maps and a detailed item location guide are included with this newsletter. Please contact a reference librarian if you are having difficulty locating an item.

Meet Murphy: The Library's Catalog

Murphy is the law library's online catalog; named in honor of the former Supreme Court Justice, Governor of Michigan, and legal research instructor at the University of Detroit Mercy School of Law, Frank Murphy.

The catalog contains item and bibliographic records for the library's monographs,

monographic sets, serials, reserves, and course reserves. Murphy will allow users not only to locate a particular title, but also to search for multiple materials by topic. It is important to note, however, that pre-1984 materials are currently in the process of being re-catalogued and may not yet be in Murphy; in these cases, please

consult a reference librarian.

Murphy is searchable by keyword, subject, author, title, call number, ISBN/ISSN/LCCN/OCLC numbers, and government document numbers. Detailed searching instructions are included in the Kresge Law Library Circulation Policy Manual (copies of the manual are

Interlibrary Loan

Just a reminder that if you are interested in an item not in our library's collection, we have an interlibrary loan service that allows our library to borrow items from other participating libraries. Please contact Jaime Palay at nelsonjt@udmercy.edu to use this service. It generally takes between one and three weeks to receive items.

Wireless Printing/Scanning

Wireless printing is available in the library for your convenience; directions for how to

configure your computer for printing are located at the circulation desk. A scanner (located next to the Lexis and Westlaw printers on the first floor) is available for faculty and students. Scanned items must be either saved to disk or portable hard drive however, as the attached computer does not have Internet access.

Searching the Collection

There is a computer located on each floor of the library with access to Murphy, KeyCite, Index to Legal Periodicals and Books, InfoTrac, LexisNexis Government Periodicals Index, and the Government Documents Catalog Server.

Westlaw

We are continuing to provide public access to Westlaw. There are four dedicated Westlaw computers on the first floor, all with printing capabilities. Users will have access to state and federal laws, cases, and administrative materials; other available

practice forms include American Jurisprudence 2d, AmJur Pleading and Practice, Federal Practice and Procedure, and West's Legal Forms. Quick reference guides are provided, and reference librarians are available to assist with research inquiries.

Study

The primary study area for students is located on the third floor; however, a limited number of individual study desks are also located throughout the library. New dedicated study rooms are available on the second and third floors; third floor rooms can be reserved for watching the Barbri videos.

We look forward to working with you all over the next year.

Common Library Abbreviations

ISBN (International Standard Book Number): ISBN is a ten-digit number that uniquely identifies books and book-like products published internationally. The purpose of the ISBN is to establish and identify specific editions and publishers.

ISSN (International Standard Serial Number): ISSN is an eight-digit number that identifies periodical publications, including electronic serials. There are currently more than one million assigned ISSN numbers.

LCCN (Library of Congress Control Number): LCCN is a serially based system used by the Library of Congress for numbering books; and, is used for authority, bibliographic and classification records.

OCLC (Online Computer Library Center): OCLC is a shared computer library service with over fifty-five thousand member libraries in one hundred and ten countries. This service allows users to locate, acquire, catalog, lend and preserve library materials.

available in the library). For successful searches, the record returned will provide the library location, call number, and circulation status. If it is discovered through searching that the library does not own a particular item and it would be a valuable addition to the collection, users can request the library purchase the item using the *Books the Library should Acquire* link on the Murphy homepage.

Access to Murphy is available on all four floors of the library (see library maps for exact locations)

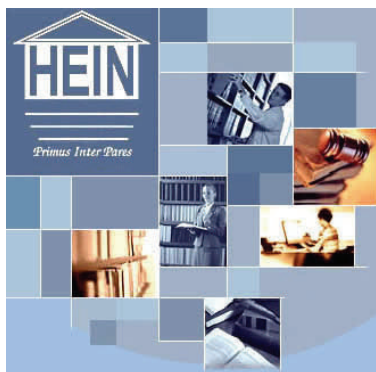

Resource Highlights

What is HeinOnline?

Lexis and Westlaw have quickly become the go-to databases in legal research. Yet, despite their incredible scope and usefulness, there are times when these two databases prove less adequate. For example, students cite checking for law reviews need articles in their original form; PDF is not available in Lexis or Westlaw. In addition, Lexis and Westlaw generally only include periodical publications after 1980. Instead of turning to a general search engine like Google, or to Interlibrary Loan services, let us suggest HeinOnline.



HeinOnline is a comprehensive, image-based, fully searchable online legal database. Exact page images in PDF format allow users to view pages as they originally appeared in print (complete with charts, graphs, and photographs). From the library computer lab and staff office computers, the database is easily accessed through the web browser homepage under *Subscribed Journals*.

The HeinOnline collection includes over four centuries of research on law, history, political science, business, public policy, government, and criminal justice. The database is divided into library modules which include the following: U.S. Federal Register Library, U.S. Treaties and Agreement Library, U.S. Supreme Court Library, U.S. Attorney General Opinions Library, U.S. Federal Legislative History Library, U.S. Statutes at Large Library, Legal Classics Library, Phillip C. Jessup Research Library, and the Presidential

Library. The collection dates back to some of the earliest legal materials (as far back as the mid 1800s).

Of particular interest is the Law Journal Library, which contains the full-text of over three hundred and seventy of the top academic law journals. The

majority of these law journals are available from the very first issue through to the most current volume allowable.

HeinOnline is an incredibly valuable resource, and one which can now be utilized from off-campus as well as from the law school.

Access Materials From Home

For a trial period, the library will be offering remote access to HeinOnline for faculty and students.

Provided below are specific instructions for accessing HeinOnline from your personal computer.

1. Go to <http://murphy.law.udmercy.edu>
2. Click on *Search the Catalog*
3. Along the right-hand side of the screen you will see a link for *Access to Databases from Home* (it's right above *Return to Main Menu*) - Click on it
4. Click on HeinOnline
5. Enter your last name and Library ID barcode (this is the number of your library card)
6. Click *Subscribers Please Click Here*
7. Begin your research
